

APPOINTMENT OF CHIEF ENGINEER (CIVIL),
SPORTS KERALA FOUNDATION ON CONTRACT BASIS

The Sports Kerala Foundation, Government of Kerala, invites **applications** for appointment of **Chief Engineer** in the Sports Kerala Foundation on contract basis:-

I. Age, Post Name, Number of Vacancies, Educational Qualification and Experience:

Name of Post	Chief Engineer
Number of Vacancies	1 post
Educational Qualification	Degree in Civil Engineering or Equivalent.
Experience	Experience as Chief Engineer / Superintending Engineer in Kerala Government Departments / CPWD / Public Sector for at least 3 years. Preference will be given to those candidates who have experience in Sports Infrastructure especially in Construction of stadia.
Age	Not to exceed 65 years

II. Period of Contract

The above post is temporary in nature, initially for a period of one year for controlling all construction / maintenance works entrusted to Sports Kerala Foundation. The period of contract may be renewed further based on organizational requirement / performance.

III. Remuneration:

Consolidated Pay (per month)

Rs.75,000/- or as per Clause 5 of G.O.(P)No. 81/2019/Fin dated 09.07.2019 whichever is lower.

(In addition travel allowance shall be eligible as per rules of Government of Kerala)

IV. **Method of Selection**

Only applicants meeting the qualification and experience requirements notified shall be informed to attend a **Personal Interview to be held at the office of Sports Kerala Foundation**, Jimmy George Indoor Stadium, Vellayambalam, Thiruvananthapuram.

V. **Qualification**

- (i) Those applicants having qualifications equivalent to any of the prescribed qualifications should submit the Certificate issued by the competent authority and without such certificate, their candidature will not be considered.
- (ii) The minimum qualification stipulated for the post must be from a University/ Institute recognized by AICTE/ appropriate statutory authority in India/ State/Central Government.

VI. **Experience**

1. Experience acquired after the date of passing of the qualification stipulated as per item I above will only be considered.
2. Experience Certificates obtained from Government Departments/ CPWD/ SAI / Companies registered under the Companies Act 1956 or Foreign Companies of equivalent status will only be considered for short listing to attend the Personal interview.
3. During the certificate verification process, the candidates should produce all certificates in original to establish the experience claimed in their online application, failing which they will not be permitted to attend the **Personal interview**.

VII. **How to apply**

1. Applicants shall submit their Bio-data in sealed cover to the Managing Director & CEO, Sports Kerala Foundation, Jimmy George Indoor Stadium, Vellayambalam, Thiruvananthapuram or forward the same to the e-mail id **careers.skf@gmail.com** from **13.03.2023 to 20.03.2023**.
2. Copies of all certificates towards proof of age, educational qualification, experience, caste, disability etc and a recent passport size colour photograph shall be attached along with the Bio-data.
3. **“Application for the post of Chief Engineer”** shall be written on the envelope.
4. Applicants should not submit more than one application. Application once submitted shall be final.

VIII. **General**

1. Applicants are advised to make sure that they are meeting the eligibility requirements for the post before submitting the applications.
2. Sports Kerala Foundation reserves the right to call for any additional documentary evidence from candidates in support of educational qualification / experience / other notified eligibility requirements as indicated in their online application, and information / replies to such queries should be only through the e-mail sportskeralafoundation@gmail.com. However, Sports Kerala Foundation will not be responsible for any delay/non-receipt of such e-mails within the stipulated date and time. Replies to any such queries received after the stipulated date and time will not be considered, and no further correspondence shall be entertained in this regard.
3. If at any stage it is found that any information furnished is false/ incorrect or the candidate does not satisfy the eligibility criteria, the candidature/appointment is liable to be cancelled/ rejected.
4. Candidates short-listed for the certificate verification / Personal interview should bring a photo identity proof (in original) like PAN Card, Aadhar, Driving License etc, and all original certificates towards proof of age, qualification, experience, caste, disability and their candidature will be considered on the strength of the original certificates. In case of failure to produce the original certificates, the candidature will be rejected.
5. Applicants who fail to produce the original certificates during the certificate verification process will not be allowed to attend the Personal interview.
6. No TA/DA will be paid to the candidates for attending the selection
7. The vacancies are purely on contract basis for the period specified and Sports Kerala Foundation is not liable to offer appointment during or after the completion of contract period of the selected candidates
8. Applicants should be of sound health and shall satisfy the medical fitness standards as fixed by the Government. A medical fitness certificate by the Medical Officer / Civil Surgeon shall be produced at the time of appointment.
9. No correspondence regarding the rejection of application in case of ineligibility shall be entertained.
